

NAADAC Approved Courses

Behavioral Health Services for Alaska

Natives 6 Hours

This course can serve as a recourse to Behavioral Health professionals who wish to provide culturally appropriate and responsive services to Alaska Native individuals.

COUNSELOR TECHNICIAN COURSES

Ethics Course 6 Hours

These courses will assist students in understanding the ethical obligations of a professional in relation to the NAADAC Code of Ethics. (Courses 2-4 are for recertification)

8 Hours

Confidentiality

These courses will provide an overview of the Federal confidentiality regulations (42 CFR Part 2 and the Health Insurance Portability and Accountability Act of 1996 (HIPAA), 45 CFR Parts 160 and 164 and the implications for behavioral health programs. (Courses 2-3 are for recertification)

Infectious Diseases and HIV/AIDS

This course focuses on hepatitis, sexually transmitted diseases, TB, HIV, and other infectious diseases that might impact clients receiving services.

Introduction to Addictive Behavior 8 Hours

This course provides an overview of the problems and consequences of substance abuse, and the importance and effectiveness of assessment procedures.

Crisis Intervention 8 Hours

This course will provide the foundational and practice information on general crisis events. It will focus on crisis responses such as depression, grief, relapse, and increased shame, lots of motivation and self-esteem, and isolating. The course will also address suicide ideation, intervention, evaluation, and follow-up.

Working with Diverse Populations 16 Hours

This course will discuss ethnicity, immigrants and refuges, women, disabilities, older adults, sexual orientation, adolescents, homeless populations and comorbidity of alcohol and psychiatric problem

Community Resource Use & Case Mgmt 8 Hours

This Course will provide an overview for coordinating client services and case management..

Introduction to Group Counseling 8 Hours

This course focuses on five group models that are common in substance abuse treatment; and group leadership.

RADACT Correspondence Courses

Recovery Health Wellness 8 Hou

Working as a helping professional can bring deep satisfaction and lasting rewards. But the ability to help people may also have a negative impact on the helper. This course will provide practical tools to manage this often high stress work differently and minimize one's risk of harm from working in the helping profession.

Substance Use Disorder in Older Adults 8 Hours

This course is designed to help providers & other better understand how to identify, manage, and prevent substance misuse inolder adults. This course covers drug & alcohol use disorder, screening tool, assessment, & treatments specifically tailored for older clients' needs; and strategies to help providers improve their older clients' overall wellness and social functioning.

LEVEL ONE COURSES

Motivational Interviewing

16 Hours

This course focuses on the principles of motivational interviewing and the Stages of Change model by DiClemente and Prochaska.

Psycho-Physiology

16 Hours

This course will provide information about the brain-body connection, the nervous system structure, neuro-anatomy, neuro-transmitters and receptor function. The course will also discuss various drugs and their effects,

Co-Occurring Disorder

12 Hours

This course will provide working knowledge of the most common co-occurring disorders seen in substance abuse treatment settings. The course will help counselors understand the role of addiction within the framework of the client's experiences and to see how the client's disorders are interrelated.

LEVEL TWO COURSES

Criminal Offenders & Sub Use Disorder 8 Hours

The course provides recommendations and best practice to individuals working in the criminal justice system and covers the full range of criminal justice settings and all the phases through which an individual progresses in the criminal justice system. The course is primarily for substance abuse counselors and clinicians who treat clients involved in the criminal justice system.

BEHAVIORAL HEALTH TECHNICIAN

Introduction to Co-Occurring Disorder 8 Hours

This course will provide a basic understanding of how mental health disorders, substance use disorders, and other related conditions can exist in combination and how they affect treat-

ment services.

4 Hours

This course will provide the theoretical concepts of documentation to augment the eight-hour in person documentation class. Although the course is focused on IOP the concepts cover all levels of treatment.

Prevention & Community Development 8 Hours

This course will provide the key features and strategies of prevention and community development promoted by the National Institute on Drug Abuse (NIDA) and Substance Abuse and Mental Health Services Administration (SAMHSA). The course will cover both prevention in early childhood (0-8 years) and the SAMHSAs Strategic Prevention Framework (SPF) prevention model that promotes resilience and prevents
